

## Terms and Conditions

No alcoholic beverages can be consumed by any person not of legal drinking age. All U.S. law enforcement agencies have absolute power to stop any motor vehicle for administrative searches. If contraband is aboard, even in negligible quantities, they can seize and forfeit this vehicle to a local government agency. Therefore no person will bring contraband aboard vehicles that are owned or operated by Boise Party Bus. All passengers ride at their own risk and must remain seated while the vehicle is in motion. We will not be responsible for injuries that may occur due to standing while the vehicle is in motion or horse play while the vehicle is in motion or at a standstill. The renter who signed this contract takes full responsibility for all guest conduct, the results of guest conduct including damage or injury, and all contents in the vehicle. It is the responsibility of the renter to inform all guests of the terms and conditions of this contract.

### **THE PURCHASER AGREES TO BE FULLY LIABLE FOR ALL CHARGES INCURRED.**

\$20.00 per broken glass or bottle, \$50.00 minimum for extensive cleanup (spills, glitter, confetti, food, candy) per occurrence  
\$150.00 detailing and wax (due to sickness-exterior) per occurrence, \$250.00 cleaning and disinfecting (due to sickness-interior) per occurrence  
\$175.00 minimum for each burn hole, rip, tear to upholstery, act of vandalism or damage incurred to the interior or exterior of the vehicle  
Boise Party Bus recommends that all and any personal valuables be removed from the vehicle when unattended. We will not be held responsible for any lost, stolen, or damaged items. Smoking, vaping, tobacco use of any kind, underage drinking, illegal drug use or possession, fighting/disruptive behavior, vomiting, sitting on seat backs or walking on the seats is not allowed in any of our vehicles and will result in immediate termination of service and all applicable charges applied, with no refunds for unused rental time. Boise Party Bus reserves the right to end service and terminate this or any other contract for non-compliance, especially if guests do not follow the driver's instructions in order to meet the conditions in this contract, maintain a safe operating environment, and obey all city, county, state and federal laws. Any down payments (cash, check, credit card, or Pay Pal) will be non-refundable, for any reason, if cancellation occurs from the renter's side. The renter authorizes the immediate down payment and the final payment, states that he/she is the authorized purchaser for this rental contract, the authorized cardholder for the given credit card, responsible and liable for payment of the total amount per cash, credit card, or pre-approved check. As with all contracts, this rental contract between the mentioned person as renter/purchaser and Boise Party Bus is made with the information given to us. The down payment and all information from the renter are binding and cannot be changed without acceptance by Boise Party Bus. If the contract is cancelled, Boise Party Bus is still authorized to collect the remaining balance in full, if the vehicle was not re-rented again on the cancelled date for the same or higher amount. The credit card holder gives authorization to use the credit card information over the phone/fax/online in combination with the contract. It is agreed that it is not necessary to obtain a signature on the contract or credit card slip, as the reservation is made over the phone/fax/online. Proof of identity of the purchaser using said credit card must be provided prior to the beginning of service. At time of pickup, we need the credit card, and state identification of the renter that authorizes the transaction for the contract. If the renter cannot provide all of the above items at the time of pickup, Boise Party Bus will not start the job, as we have no proof of the legal possession of the credit card. Therefore, the risk of not getting paid will give us the right to cancel. The renter is still fully responsible to pay the total amount as he/she failed to meet the above requirements. Boise Party Bus cannot guarantee the availability of overtime. It is of particular importance that the renter makes allowances for anticipated and unanticipated delays and adheres to the agreed time schedule and planned destinations. In the event that the renter wants to change the time or destinations, they may do so, only if Boise Party Bus can accommodate other clients that booked with us, prior to or after the said time. The renter further agrees to pay additional charges incurred such as overtime, tolls, parking, etc. Overtime or transfer jobs are charged to the credit card on file in 15 minute increments, extra stops are charged \$ 30.00 each. Transfer jobs are priced for immediate pickup / drop-off, no wait time is included, no usage of bar or drinks/food etc. Base price is for simple transportation. If customer fails to show at the designated pick up location, the full amount of contracted time will be charged. The purchaser authorizes Boise Party Bus to charge any additional fees after they have rendered services to the renter's credit card as supplemental charge. A 15% gratuity may be added to your total charge. Final payment is due at or before the beginning of the rental time. Customer agrees to have Boise Party Bus get an authorization for the credit card and amount of each rental. If any payment due hereunder will be unpaid (10) ten days after the due date, hereon Boise Party Bus will have the right to add and collect late charges with interest at maximum rate allowed by law. All such sums are due and owing with any other expenses, (filing fees, court cost, and reasonable attorney fees, etc). Necessarily, injuries by reason of such non-payments, I the credit card holder/purchaser agree to pay Boise Party Bus upon making the reservation and placing the down payment. I am satisfied with the terms and conditions above and fully understand and agree. If, for any reason, I am not fully satisfied with the services I receive, I have 12 hours after the completion of the job to file a complaint in writing. If Boise Party Bus does not receive my written complaint in the above stated timeframe, I agree that there is no valid complaint and I am fully satisfied with the services that I received. Filing a written complaint insures both parties, that it is fully understood what the problem was, and should help Boise Party Bus to assist the purchaser in securing a resolution. The purchaser will be contacted within a week of the complaint to settle the matter. I understand that this is a separate case from the main contract and therefore have no dispute in general against Boise Party Bus and the payment I authorized. Boise Party Bus does not provide music, video or any other type of onboard entertainment with our service. Use of any power-operated equipment may be subject to temporary failure. This will of course not interfere with the safety of the vehicle itself and therefore will have no effect on continuing or paying of the contracted trip. Boise Party Bus guarantees that all our vehicles are routinely checked to keep the highest possible standards and eliminate such failures as much as possible. Boise Party Bus agrees to send the requested vehicle as offered in the contract. We have the right to upgrade the vehicles or switch the vehicles in case of emergency, breakdown or if vehicles were in accidents. If no other vehicle is available, passengers will be responsible for their own transportation from the emergency/breakdown. No additional charges will occur on customer side if upgrade is made without customer request. If switching occurs in the same category, or upgrades are made, it will not affect the contract and/or payment of contract. Customers therefore accept that replacement vehicle may be substituted if contracted vehicle becomes unavailable for any reason. Boise Party Bus will terminate service immediately in the presence of unsafe weather/road/operating conditions and no further transportation options will be provided. If any of our above guarantees or contracted terms cannot be met due to conditions outside of our control, including weather, accidents, mechanical malfunction, or any other acts of god, we will use our best efforts to notify the renter of these conditions and resulting delays or termination of services.
